<b>Meeting Notes</b>
<ul style="list-style-type: none"> <li>• Meeting was convened by Tonmoy Dasgupta at 9:32am.</li> <li>• Deputy Commissioner Chrisman explained that Rule 106 was being modified in 2017 to cover the data driven automation methods used in Arkansas Network Adequacy Regulation Program. She explained that at the time Rule 106 was originally drafted, the expectation was to use manual methods but with the amount of data involved in Network Adequacy review, the Department was forced to use data driven analytic methods. She welcomed comments from issuers for consideration in the modification of Rule 106.</li> <li>• Deputy Commissioner Chrisman reiterated that the Department was not planning on adding new Provider Types in the near future unless pushed by external stakeholders citing network inadequacy cases.</li> <li>• Tonmoy Dasgupta provided the update that the "mid-Year" PY2017 Network Adequacy review was being delayed and that the PY2017 marketplace issuers were not required to provide updated <i>AR Specialty Access</i> and <i>ECP/NA</i> templates as expected on October 1, 2017.</li> <li>• Tonmoy Dasgupta covered the slides of what was expected of the issuers in the mid-Year PTNP review. He explained that the mid-Year PTNP update would consider only the issuer feedback for processing. (Since Tonmoy Dasgupta's narration did not digress from the materials in the slides, the meeting notes does not duplicate the information and the reader is advised to refer to the slides).</li> <li>• Tonmoy Dasgupta ended the meeting at 10:17am.</li> </ul>
